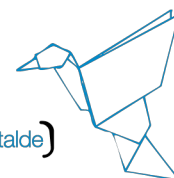


## Joint PhD Position in Mathematical Modelling for Cancer Research

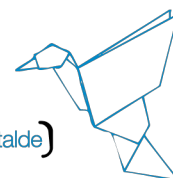

Topics:	<p><b>Tracking development of resistance to anti-cancer therapy through mathematical modeling</b></p> <p>The goal of the project is to derive an efficient mathematical approach for tracking development of resistance to anti-cancer therapy using genomic information. The proposed project includes statistical analysis of the available real data; building a predictive model and implementing it in the in-house software package; simulations and post-processing of the simulation data.
