

## Cookies Policy

BCAM, through this document, collects its policy of collection and processing of cookies, in compliance with the provisions of Article 22.2 of Law 34/2002, of July 11, Services of the Information Society and Electronic Commerce.

Cookies are stored in the user's terminal equipment (computer or mobile device) and collect information when visiting BCAM's web pages (, <http://www.bcamath.org/en/>, <http://www.bcamath.org/es/> and <http://www.bcamath.org/eu/> and <http://wp.bcamath.org/>), with the aim of improving their usability, knowing the habits or browsing needs of users in order to adapt to them, as well as obtaining information for statistical purposes.

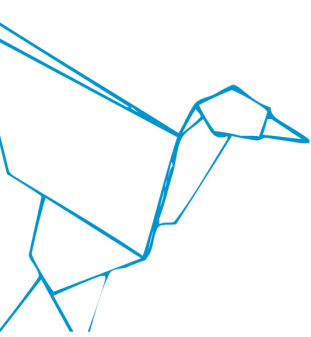
This Cookies Policy applies to those users who voluntarily visit BCAM's web pages, complete data collection forms, or use any other service on the website that involves the communication of data to BCAM, or access to data by BCAM for the provision of its services. The fact of continuing to navigate through its pages implies the knowledge and acceptance of this Policy by such users.

BCAM uses the following types of cookies:

- Classified by ownership:
  - Own cookies: sent and managed directly by BCAM.
  - Third party cookies: sent and managed by a third party outside BCAM, anonymously, with the purpose of carrying out statistical studies of navigation through BCAM's web pages.
- Classified by purpose:
  - Cookies for analysis and / or advertising: to know the number of visits received in the different sections of the website, habits and trends of its users and consequently, to improve navigation and service offered by BCAM (mainly, Google Analytics). It collects data anonymously in order to obtain navigation profiles of users.
- Classified by duration:
  - Session Cookies: collect and store data while the user is accessing the website.
  - Persistent cookies: they collect and store data in the user's terminal for a variable period of time depending on the purpose for which they were used.

The shelf life of cookies will depend on the type of cookie and will always be the minimum necessary to fulfil their purpose.

In any case, users can configure their browser to disable or block the reception of all or some of the cookies. The fact that you do not wish to receive these cookies does not



prevent you from accessing the information on BCAM's websites, although the use of certain services may be limited. If, once consent has been granted for the reception of cookies, the user wishes to withdraw them, those stored on the user's computer must be eliminated through the options of the different browsers.
